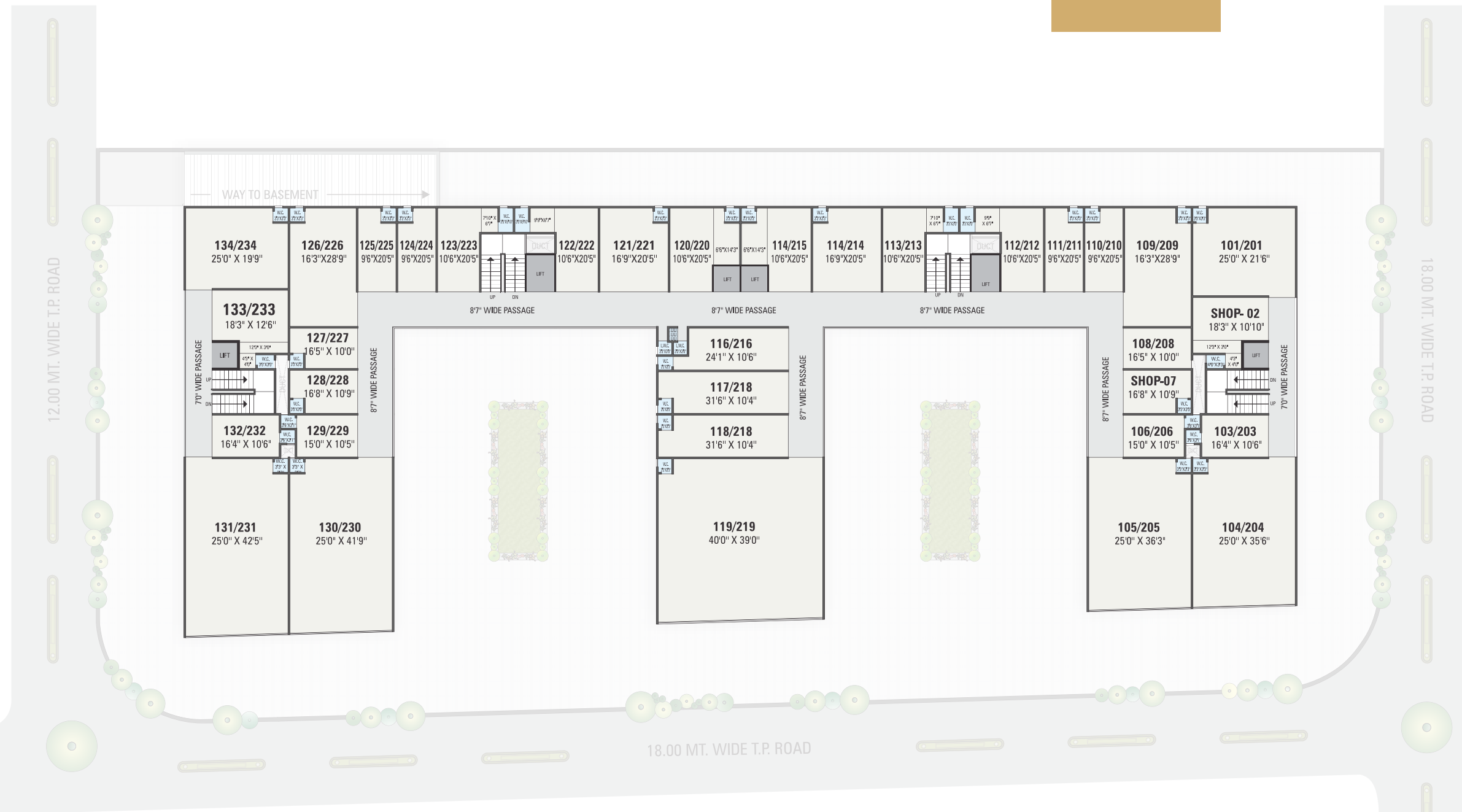
GROUND FLOOR TYPICAL PLAN
